

## Nyon Triathlon regulations, 2021 edition

When registering for the Nyon Triathlon, the participant pledges to:

1. Scrupulously respect all the terms presented in the current regulation, as well as the various rules featured on the event's website ([www.trinyon.ch](http://www.trinyon.ch)).
2. Respect without reservation the competition regulations of Swiss Triathlon ([www.swisstriathlon.ch](http://www.swisstriathlon.ch)).
3. Respect without reservation the principles of the Code of ethics in sport by Swiss Olympic ([www.swissolympic.ch](http://www.swissolympic.ch)).
4. To fully respect the protective measures put in place by the organizers due to the current sanitary situation; depending on the rules set by the government authorities, these could evolve up until the last moment.
5. Submit to antidoping examinations, possible at all time. The applicable antidoping guidelines can be consulted at [www.antidoping.ch](http://www.antidoping.ch). The list of banned substances and methods as well as authorised medication can be consulted and downloaded.
6. Deny all responsibility of the Organising Committee and volunteers of the Nyon Triathlon in the case of an accident, damage, loss and/or theft of equipment.
7. Be in perfect health and prepared to take part in the Nyon Triathlon, and present no contraindication to the practice of triathlon.
8. Respect the Swiss traffic laws and legislation, due to the courses not being entirely closed to circulation.
9. Wear his/her timing chip for the duration of the race and return it after reaching the finish line. In case the participant has forgotten to do so, he/she commits to send the chip by mail to the Nyon Triathlon within the 5 days following the competition. Non-returned chips will be charged CHF 50.- each.
10. Be in possession of a liability insurance in effect and valid in Switzerland.
11. Be in possession of a health and accident insurance in effect and valid in Switzerland.
12. Be in possession of an insurance against natural damage (ECA type) in case of damage of his/her equipment due to natural element (storm, hail, etc.) or accept to bear responsibility of caused damage, even if the said equipment is in zones securised by the organiser. The subscription to an insurance safeguarding these risks is the responsibility of the participant and the organiser disclaims any responsibility in case of damage.
13. Adopt an environmentally conscious attitude before, during and after the race, and use the spaces provided for the recycling of trash.
14. If no cancellation insurance has been contracted when registering online, refund of the registration fee is only possible on presentation of a medical certificate.
15. If the participant is a minor, he/she must be authorised by his/her parents to participate in the Nyon Triathlon and is not under 5 years of age at the moment of his/her participation in the Nyon Triathlon.
16. If the competitor does not have the required equipment (wet suit if required, helmet, etc.) or in case of cancellation of the event due to weather, force majeure, external events or extraordinary circumstances, no entry will in principle be refunded.
  - Due to the exceptional circumstances related to the pandemic of Covid-19, the organizers accept to consider a refund of part of the registration fee under certain conditions. First of all, the person must already be registered at the time of cancellation and the event must be cancelled - or not authorized - by the authorities because of the evolution of the Covid-19 pandemic.

- In such a case, a request on behalf of the participant must be made to the organizers within the time limit transmitted by them. If the request is not made within the deadline, no refund will be made nor will the registration be postponed to 2022.
- Due to the costs incurred by the organizers, who are all volunteers, the amount reimbursed will be degressive according to the date of a possible cancellation, i.e. :
  - Up to 4 months before the event (7.4.2021) = 75% refund
  - Up to 3 months before the event (7.5.2021) = 50% refund
  - Up to 2 months before the event (7.6.2021) = 25 % refund
  - From two months before the event (8.6.2021) = 0% refund
- This partial refund will only be made if requested by the participant.
- Any participant would have the possibility to donate the amount of his/her registration to the organizer in order to help offset the expenses already incurred for the event.

Furthermore, the participant :

17. Authorises the Nyon Triathlon to store and publish personal data (starting list, results, etc.), as well as publish photos taken during the competition, whether on the website, promotional material or any other material support of the event. In case of disagreement, the participant will notify the organiser in writing (electronic mail accepted) at the latest on the day of the event.
18. Authorises the organiser to add him/her to the mailing list of the event's newsletter. In case of disagreement, the participant will notify the organiser in writing (electronic mail accepted) at the latest on the day of the event or will unsubscribe directly through the link indicated at the end of the newsletter.
19. Agrees that the Nyon Triathlon reserves the right to transfer the data of participants aged 16 years and older, namely name, surname and e-mail address, to the organisers of the Geneva Triathlon, the Lausanne Triathlon and the Yverdon-les-Bains Triathlon, for the promotion of their respective events by the means of newsletters and/or e-mails. The Nyon Triathlon undertakes measures to ensure that the previously mentioned events don't transfer this data to any other third party. In case of disagreement, the participant will notify the organisers in writing (electronic mail accepted) when registering for the race.
20. Is advised that apart from the elements described in point 12, 13 and 14, the participant's data will not be transferred to third parties, whether a company, a sponsor or an organiser not named in point 14.
21. Agrees that, for the remainder, the elements described in the privacy statement of Datasport (timekeeper of the competition - /www.datasport.com/en/privacy-statement/) applies without restriction to all the participants registered to the Nyon Triathlon.
